'Cyber-bully' Accused of Driving Girl to Suicide Faces 20-Year Term by Rupert Cornwell

May 17, 2008, Washington - A Missouri woman accused of pretending to be a smitten teenage boy on MySpace and driving a 13-year-old girl to suicide with cruel messages faces federal charges that could lead to 20 years in jail.

Prosecutors say Lori Drew, 49, and others created the fake persona of a 16-year-old boy to woo her neighbour Megan Meier for weeks on the social networking site, then suddenly ended the relationship, telling her the world would be better off without her.

May 21, 2008, Albany, NY (CNN) - At the age of 21, Christopher Jenkins appeared to have everything going for him. The University of Minnesota senior was good-looking, had a near perfect grade-point average and had a future in business. Then, suddenly, he vanished.

He was last seen celebrating Halloween at a bar in downtown Minneapolis, Minnesota, in 2002. Jenkins' friends said he left about midnight. Four months later, his body was found in the Mississippi River, still wearing his Halloween costume.
