Smyth and Schwarzenegger Team Up To Fight Pedophiles by Jon Dell

Hometown Station, August 29, 2007 - Smyth's bill to get Governor's helping hand. Assemblyman Cameron Smyth has won a major ally in the fight to end the actions of pedophiles. Governor Arnold Schwarzenegger has signed on to back the Smyth authored Assembly Bill 534, otherwise known as the "Surrogate Stalker Act." The legislation is joint-authored by Assembly members Todd Spitzer and Sharon Runner.

The bill was introduced under emergency proceedings and the Governor has pledged his commitment to work to get the bill passed.
